This agreement is for the position as a “Illustrator” at Three Little Sisters [DBA: Little Bird Books & The Real Saga Press]. The “Illustrator(s)” is a free agent not bound or employed by Three Little Sisters [DBA: Little Bird Books & The Real Saga Press] and therefore is not provided any benefits.

ROYALTIES & ACCOUNTING: “Illustrator(s)” are provided a 5% royalty for all projects unless they are the primary and sole illustrator on a single “Author” project, at that point the “Illustrator” can be provided up to a 50% royalty. All royalties will be provided in the offer to the “Illustrator(s)”. The “Publisher” also will not and is not responsible for the preparation of the taxes for the “Illustrator”. Taxes are taken prior to distribution of the royalty payments. All “Illustrator(s)” should make sure they report income from royalties in compliance with the law of their respective countries.

FILE FORMATS ACCEPTED: The “Illustrator(s)” will be expected to provide all art in digital form, sent by either email or provided by secure document transfer to the “Publisher” in 300dpi or higher, with transparent background.

COPYRIGHT & CREATIVE COMMONS\FAIR USAGE: The “Work” must be kept confidential by the “Illustrator” and may not be shared, distributed or otherwise transferred to any party without explicit permission from the “Publisher”. The art commissioned by the “Publisher” is not for public view. “Illustrators” are prevented from showing, distributing or posting images of the art they are working on until a press kit is either released or publication has been made of the “Work(s)” and only then under a CREATIVE COMMONS for strictly artistic portfolio use **with proper credits provided** for the image whereas the WORK TITLE, AUTHOR, PUBLISHER within the description of the art.

ILLUSTRATOR CONDUCT: The “Freelance Editor(s)” are expected to refrain from disparaging the “Publisher” in any form both online and offline. IF an error is noted by the “Freelance Editor(s)” it should be reported via email or private message to general@thethreelittlesisters.com and we will correct it. IF a “Freelance Editor(s)” is found to be making disparaging comments, their contract will be terminated immediately.

CONTRACT TERMINATIONS: This contract must be terminated in writing 30 days prior to the termination date required in order to retain royalties due. IF the “Illustrator” quits during the production period, cancels the contract prior to the deadline date, fails to complete the project will be subject to loss of royalties earned.
